

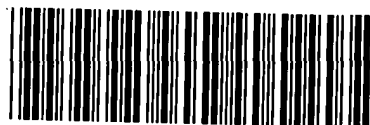

**ORDER**

---

UPON the Applicant's Application dated 24 September 2021

AND UPON hearing Counsel for the Applicant

AND UPON the First Respondent not attending and not being represented but being served in accordance with section 1140 of the Companies Act 2006

AND UPON the Second Respondent indicating it has no objection to the order sought

AND UPON notice being given to the Receivers of Savants Restructuring Limited by first class letter dated 27 September 2021

**IT IS ORDERED that:-**

1. Pursuant to Section 108 of the Insolvency Act 1986 ("the Act") and Rule 12.36(2) of the Insolvency Rules 2016 ("the Rules") and with effect from the date of this Order:
  - 1.1. the First Respondent is removed from office as liquidator of the companies in members' voluntary liquidation listed in Schedule 1 attached hereto, and Carl Jackson and Michael Hall of Quantuma Advisory Limited ("the Successor Practitioners") are appointed as joint liquidators of the companies listed in Schedule 1 attached hereto; and
  - 1.2. the First Respondent is removed from office as liquidator of the companies in creditors' voluntary liquidation listed in Schedule 2 attached hereto, and the Successor Practitioners are appointed as joint liquidators of the companies listed in Schedule 2 attached hereto.
2. For the avoidance of doubt, the appointments under paragraph 1 take effect under s.108(1) of the Act in respect of any appointment taken by the First Respondent after 3 September 2020.
3. Pursuant to sections 298 and 303 of the Act and Rule 12.36(2) of the Rules and with effect from the date of this Order, the First Respondent is removed from office as Trustee in Bankruptcy in the bankruptcies of the individuals listed in Schedule 3 attached hereto, and the Successor Practitioners are appointed as joint Trustees in Bankruptcy of the individuals listed in Schedule 3 attached hereto.
4. The Successor Practitioners shall act such that one or more may act for the other.
5. Where required a relevant notice required to be filed at Court be filed at the same time as the next notification as required pursuant to statute.
6. The Successor Practitioners shall give notice of their appointment and the making of any Order to all creditors of the estates listed in Schedules 2 and 3 to the Order and members of the companies in members' voluntary liquidation listed in Schedule 1 to this Order within 28 days of the date of the Order by way of one composite advertisement in the London Gazette. Such notice to include the following matters:
  - 6.1. an explanation as to the effect of the Order of the Court; and
  - 6.2. express reference to the liberty to apply as set out in this Order of the Court.

7. All creditors of the estates listed in Schedules 1 to 3 to the Order have permission to apply to the Court, on notice to the Successor Practitioners within 28 days of advertisement referred to in paragraph 6 above, to vary or discharge the Order insofar as it affects the estate or estates of which they are a creditor.
8. For the avoidance of doubt, the First Respondent is prohibited from withdrawing any monies whatsoever, whether in respect of outstanding remuneration or otherwise, from the estates of the appointments in Schedules 1 to 3 to the Order without the permission of the Court or the written consent of the Successor Practitioners.
9. The First Respondent must, as soon as practicable and in any event within 14 days of the date of service or notice of this Order, transfer to the Successor Practitioners any monies and/or other assets in his possession, custody, power or control which belong to any of the estates listed in Schedules 1 to 3. If any such monies or other assets come into the possession or control of the First Respondent thereafter, they must also be transferred to the Successor Practitioners forthwith. Within 14 days of the date of service or notice of this Order the First Respondent shall inform the Successor Practitioners by email of such monies or other assets in his possession or control and the steps he has taken or is taking to comply with this Order.
10. The First Respondent (whether by himself, his agents, his employees or otherwise howsoever) must permit the Successor Practitioners and / or their employees or agents to attend during normal business hours the First Respondent's business premises including at Savants Restructuring Limited, 83 Victoria Street, London SW1H 0HW (the "Premises") on 30 September and 1 October 2021 and on such other dates as the Successor Practitioners may reasonably require, so that the all of the documents and articles listed in Schedule 4 to the Order which are capable of being delivered up for collection in respect of the companies and individuals listed in Schedules 1 to 3 to the Order can be delivered up to the Successor Practitioners, including but not limited to:
  - 10.1. Vision blue and/or IPS records;
  - 10.2. time records;
  - 10.3. physical files and documents; and
  - 10.4. electronic case files.
11. Subject to paragraph 9 above, all books and records listed in Schedule 4 to the Order of the companies and individuals listed in Schedules 1 to 3 to the Order which are in the possession or control of the First Respondent shall be delivered up by the First Respondent (whether by his storage agent(s) or otherwise howsoever) directly to the offices of the Successor

Practitioners at Quantuma Advisory Limited, Office D, Beresford House, Town Quay, Southampton SO14 2AQ within 7 days of service or notice of the Order.

12. If any of the documents and articles listed in Schedule 4 to the Order in respect of the Companies listed in Schedule 1 to the Order are held by any other person or persons, the First Respondent shall inform the Successor Practitioner of their location with immediate effect and in any event within 7 days of the date of service or notice of the Order.
13. The First Respondent do pay the Applicant's costs of the Application within 14 days to be assessed if not agreed.
14. Liberty to Apply.
