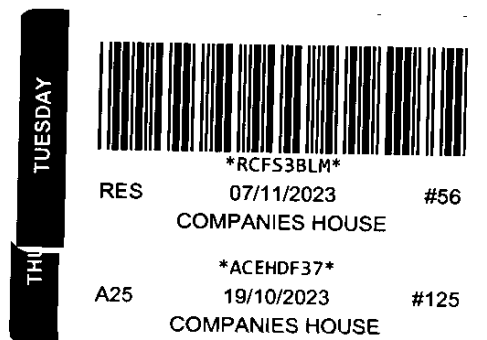

**1 Statutory information**
