ACCRUING DAILY AND COMPOUNDING ANNUALLY LESS ANY DIVIDENDS RECEIVED A DESCRIBED IN (A) ABOVE. PRE-EMPTION RIGHTS. HOLDER(S) OF CONVERTIBLE PREFERENCE SHARES HAVE THE RIGHT TO PARTICIPATE IN ANY ISSUANCE OF NEW ORDINARY SHARES OR OTHER SECURITIES BY THE COMPANY. BOTH BEFORE AND AFTER THE CONVERSION DATE, PROPORTIONATELY TO THE INVESTOR'S HOLDING IN THE COMPANY'S SHARE CAPITAL ON A FULLY DILUTED BASIS AT THE RELEVANT TIME.
