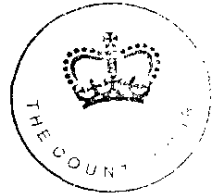

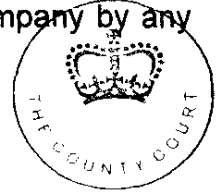

- (A) immediately on the restoration of the Company to the Register inform the Registrar of Companies of the title and Court reference number of the litigation issued against the Company seeking to enforce the Judgement against the Company in the sum of £12,018 in respect of the Claimant's successful claim against it arising out of the construction of a kitchen at the Claimant's property referred to in the 1st to 7th paragraph of the Further Witness Statement of Eilish Dundon dated 24th March 2023.

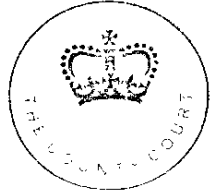
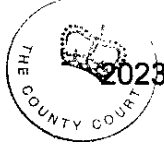
AND UPON the Claimant and the solicitor for the Registrar of Companies (the Defendant) both consenting to this Order

- (3) an Office Copy of this Order be delivered to the Registrar of Companies and pursuant to the above mentioned Act the company is thereupon to be deemed to have continued in existence as if its name had not been struck off
- (4) the Registrar of Companies do advertise notice of this Order in her official name in the "London Gazette"
- (5) the Claimant do pay to the Registrar of Companies her costs of the said Application in the agreed sum of £300.00
