In accordance with Chapter 2 of Part 13 of the Companies Act 2006 (the **CA 2006**), the following resolutions were duly passed as special resolutions on 15 December 2021 by way of a written resolution.

SPECIAL RESOLUTION

1. New Articles of Association.

That the Articles of Association of the Company be modified by the implementation of the new attached Articles of Association.

2. Authority to allot.

That the Directors be generally and unconditionally authorised to exercise any power of the Company to offer, allot or grant rights to subscribe for, or convert securities into, or otherwise deal in, or dispose of, any shares in the Company in accordance with section 551 of the Companies Act 2006, to any person, at any time and subject to any terms and conditions as the Directors think proper, provided that such authority:


- a. shall be limited to a maximum nominal amount of £109.11
- b. shall only apply insofar as the Company has not reviewed, waived or revoked it; and
- c. may only be exercised for a period of five years from the date this resolution is passed, save that during the period of the authority the Directors may make an offer or agreement which would, or might, require shares to be allotted after the expiry of such authority (and the Directors may allot shares in pursuance of such offer or agreement as if such authority had not expired).

3. Dis-application of pre-emption rights.

That, in accordance with section 570 of the Companies Act 2006, the Directors be generally empowered to allot equity securities (as defined by section 560 of the Companies Act 2006) pursuant to the authority conferred by the Articles of Association of the Company or the resolution above (as applicable), as if section 561

of the Companies Act 2006 did not apply to any such allotment provided that this power: (i) shall be limited to a maximum nominal amount of £109.11 and (ii) shall expire 6 months from the date this resolution is passed (unless renewed, varied or revoked by the Company prior to or on that date).
