### PART 1 - GENERAL DESCRIPTION OF THE COMPANY'S ACTIVITIES AND IMPACT

Activities run for our target group during our first year:

- weekly singing group, free of charge (20 attendees)
- weekly yoga classes (30 attendees)
- mindfulness courses, free of charge (25 attendees)
- 8-week archery course (12 attendees)
- drop-in sessions, free of charge (45 attendees)
- writing group, free of charge (12 attendees)
- various social events, free of charge (35 attendees)
- kayaking sessions (6 attendees)

We have referred 8 people with severe difficulties to our own volunteer counsellor for help and have had a number of people forwarded to us by mental health and CCG groups around the area.

We have received expressions of interest from 350 other people with whom we have begun engagement through a recent publicity campaign.

In the pipeline we have our own archery club, gardening group, walking group and others which we have been working on over the last 2-3 months.

We have a good number of volunteers giving their time and skills for free in order to help raise awareness and funds to further our aims, and have had lots of support from local councils, councillors and community leaders.

**PART 2 – CONSULTATION WITH STAKEHOLDERS –**

While our organisation specifically aims to tackle the loneliness and isolation of men, who we would consider our main stakeholders, we are finding that we are increasingly interacting with women who are sharing the same problems. Only our yoga classes have an exclusively male take-up, mainly due to the 'blokey' nature of the sessions; every other activity has female participants.

After an extremely successful leaflet campaign, we had just over 200 people complete an online questionnaire detailing what they'd like to see us provide. We're currently working through the most popular of those.
