This year the company received charitable grants from Local Giving, Boshier Hinton Foundation, Birmingham Sports Fund, John Middlemore Charitable Trust, Birmingham Bodenham Trust, Veolia Trust, Love Brum, and Sport England. It has also received charitable donations from individuals. The company used these funds to run 46 sessions for children with disabilities from Birmingham, which have taken place in various sites across Birmingham and Sandwell. The grants and donations have allowed the company to run sessions, including transportation, resources, and staffing, free of charge to the parents and carers of the children. 50 children benefitted from projects this year by attending sessions.

- Children have spent time outdoors with others, reducing their social isolation and improving their physical and mental wellbeing.
- Children have explored interests and developed independence by choosing how to spend their time while at sites such as an allotment.
- Children have learnt about food and healthy eating by growing and harvesting vegetables, and learnt about exercise and fitness through various sports sessions.
- Children have engaged with the places and people of their community by visiting local parks and nature reserves, and meeting members of the local community at an allotment site.
- Children have had experiences not always available to those with disabilities.

The company stakeholders are the three Directors: Kate Millington, Catriona Gray, and Steffi Earle, who have reviewed and approved these accounts.
