1. General information

SAF2 Limited is a private company limited by shares, incorporated in England and Wales. Its registered office is The Embassy Tea House, 195-205 Union Street, London, SE1 0LN.

The company is dormant and has not traded since its incorporation on 17 August 2017.

2. Accounting policies

2.1 Basis of preparation of financial statements
