1. General information

SAF6 Limited is a private company limited by shares, incorporated in England and Wales. Its registered office is The Embassy Tea House, 195-205 Union Street, London, SE1 0LN.

The company is dormant and has not traded since its incorporation on 17 August 2017.

2.1 Basis of preparation of financial statements
