Pursuant to Chapter 2 of Part 13 of the Companies Act 2006, the directors of the Company propose that the following resolutions be passed as ordinary and special resolutions (as indicated) (together, the "Resolutions").

ORDINARY RESOLUTION

THAT the terms of, and the transactions contemplated by, each of the documents listed below (the "Documents") and their execution (whether as a deed or under hand), delivery and performance by the Company be and are hereby approved (subject to such changes being made to the Documents as any director of the Company may, in their absolute discretion, think fit):

- an amendment and restatement agreement relating to a facilities agreement originally dated 1 June 2021 and amended and restated on 28 February 2022 entered into between (1) Cushon Holdings Limited as New Parent (the "New Parent"), (2) the Company as CGL, (3) Cushon MT Limited as Borrower, (4) the New Parent and certain of its subsidiaries (including the Company) as listed therein as Guarantors, (5) Ashgrove Specialty Lending Investments I Designated Activity Company as Lender, (6) AshGrove Capital Management Ltd. as Agent and (7) AshGrove Capital Management Ltd. as Security Agent (the "Amendment and Restatement Agreement");
- a supplemental debenture governed by English law to be entered into between, amongst others, (1) the New Parent, (2) the Company and (3) AshGrove Capital Management Ltd. as Security Agent (the "Debenture");
- 1.3 a deed of novation between (1) the Company, (2) Major Oak Limited and (3) the New Parent (the "Deed of Novation"); and
- 1.4 any further documents, deeds, instruments, agreements, powers of attorney, notices, requests (including but not limited to any utilisation requests, howsoever defined), acknowledgments, memoranda, statements or certificates as may be ancillary, necessary, desirable, required or requested in connection with the Amendment and Restatement Agreement, the Debenture and/or in contemplation of the transactions therein; and

THAT notwithstanding any provisions of the Company's articles of association or any personal interest of any of the Company's directors, the Company's directors be and are hereby empowered, authorised and directed to execute and deliver the Documents for and on behalf of the Company (in such manner and subject to such changes as the directors, in their absolute discretion, think fit).

SPECIAL RESOLUTION

THAT the definition of "Investment Agreement" in article 1.1 of the Company's articles of association be deleted and in substitution, there be inserted ""Investment Agreement" means the investment agreement entered into between the Investors, the Founders and the Company on 1 June 2021 as amended by a deed of accession, subscription and amendment dated 14 January 2022 and novated to the company's parent Cushon Holdings Limited pursuant to a deed of novation dated on or around the Adoption Date."

THAT the definition of "Crimson Management Incentive Plan" in article 1.1 of the Company's articles of association be deleted and in substitution, there be inserted ""Crimson Management Incentive Plan" means the share options granted or to be granted to certain managers over Ordinary Shares under the Cushon Share Option Plan."

THAT a new article 16.3 shall be inserted:

Notwithstanding anything contained in these articles:

- (a) the directors shall promptly register any transfer of any shares which are the subject of a security interest where the relevant transfer is:
 - (i) to the holder of the security interest (or to its nominee or any other entity acting on its behalf); or
 - (ii) to any other person on any enforcement of that security interest, whether that transfer is made by the holder of the security interest (or its nominee or any other entity acting on its behalf) or by any receiver; or
 - (iii) by any insolvency practitioner in the course of selling those shares,

each being a Secured Institution; and

(b) in connection with any share transfer of a kind referred to above, no transferor (or proposed transferor) of any shares in the Company shall be required to offer those shares to any of the shareholders of the Company, and no shareholder shall have any right (whether under the Articles or otherwise) to require such shares to be transferred to them whether for consideration or not.

THAT a new article 16.4 shall be inserted:

The directors shall not issue any share certificates (whether by way of replacement or otherwise) without the prior written consent of (or on behalf of) all (if any) Secured Institutions (as defined in Article 16.3 above).

THAT a new article 16.5 shall be inserted:

Notwithstanding anything contained in these articles, any lien on shares which the Company has shall not apply to shares which have been charged by way of security to a Secured Institution.
