

This written resolution will come into effect on the date on which we, as sole member of the Company, sign this written resolution.

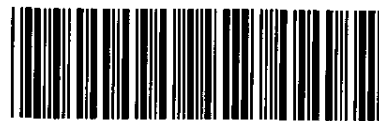
