Summary of significant accounting policies and key accounting estimates

Statement of compliance

Basis of preparation

Trade debtors

They are subsequently measured at amortised cost using the effective interest method, less provision for impairment. A provision for the impairment of trade debtors is established when there is objective evidence that the company will not be able to collect all amounts due according to the original terms of the receivables.
