The accounts for the period ended 30 June 2021 are set out on pages 3 to 4. The company did not trade during the period.

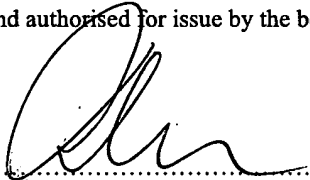
DIVIDENDS

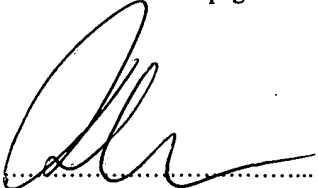

1. ACCOUNTING POLICY

The financial statements have been prepared under the historical cost convention and in accordance with applicable United Kingdom law and accounting standards.
