The directors submit their report and the financial statements for the year 31 July 2021.

#### PRINCIPAL ACTIVITIES

The principal activity is the operation of franchising activities in Thailand on behalf of the North London Collegiate School. Any profits made are gifted to the school to support the school's charitable objectives.

#### **RESULTS ACTIVITIES AND FUTURE PLANS**

The Company is not currently trading. The company did make a small loss in the year. However, the directors are comfortable that the accounts have been prepared on a going concern basis because there is continued financial support from NLCS International, the parent entity, for the Company to continue conducting its principal activities of developing franchising activities in Thailand.

#### **RISK ASSESSMENT**

The Board of Directors are responsible for the management of the risks faced by North London Collegiate School Enterprises Thailand Limited. The detailed considerations of the risks are delegated to the Chief Operating Officer of North London Collegiate School.

The key risks are identified as:

- Failure to safeguard the reputation and brand of North London Collegiate School
- Financial loss
- Operational impact on North London Collegiate School
- Legal impact
- Political change

The Board of Directors review actual financial results quarterly and compare the performance against budgets and forecasts and define spending limits.

#### **GOING CONCERN**

The COVID-19 pandemic has continued to be felt globally. The impact of the pandemic on North London Collegiate School Enterprises Thailand Limited has been assessed. The trading operations of the company ceased in the year ending 31 July 2021. NLCS International continues to provide ongoing financial support. The COVID -19 pandemic will have no impact on the company's operating position.

The company is part of a group which includes all North London Collegiate International trading entities. Cash is managed at a group level. The company has adequate resources to continue its future activities and there are no material uncertainties over the companies viability. Accordingly the going concern basis has been adopted in preparing the financial statements.

#### **DIRECTORS**

The directors who held office during the period are as stated on page 2 of this report. No director held any interest in the shares of the company, and no director received any remuneration in respect of his appointment.

Each of the directors have confirmed that so far as they are aware, there is no relevant audit information of which the company's auditor is unaware, and that they have taken all steps that they ought to have taken as a director in order to make themselves aware of any relevant audit information and to establish that the company's auditor is aware of that information.

#### **Opinion**

#### Extent to which the audit was considered capable of detecting irregularities, including fraud

Irregularities, including fraud, are instances of non-compliance with laws and regulations. We identified and assessed the risks of material misstatement of the financial statements from irregularities, whether due to fraud or error, and discussed these between our audit team members. We then designed and performed audit procedures responsive to those risks, including obtaining audit evidence sufficient and appropriate to provide a basis for our opinion.

We obtained an understanding of the legal and regulatory frameworks within which the company operates, focusing on those laws and regulations that have a direct effect on the determination of material amounts and

disclosures in the financial statements. The laws and regulations we considered in this context were the Companies Act 2006 and financial reporting standards. We assessed the required compliance with these laws and regulations as part of our audit procedures on the related financial statement items.

In addition, we considered provisions of other laws and regulations that do not have a direct effect on the financial statements but compliance with which might be fundamental to the company's ability to operate or to avoid a material penalty. We also considered the opportunities and incentives that may exist within the company for fraud. The laws and regulations we considered in this context for the UK operations were taxation legislation.

Auditing standards limit the required audit procedures to identify non-compliance with these laws and regulations to enquiry of the directors and other management and inspection of regulatory and legal correspondence, if any.

We identified the greatest risk of material impact on the financial statements from irregularities, including fraud, to be within the override of controls by management. Our audit procedures to respond to these risks included enquiries of management and the Board about their own identification and assessment of the risks of irregularities, testing on the posting of journals, reviewing accounting estimates for biases, reviewing regulatory correspondence, and reading minutes of meetings of those charged with governance.

Owing to the inherent limitations of an audit, there is an unavoidable risk that we may not have detected some material misstatements in the financial statements, even though we have properly planned and performed our audit in accordance with auditing standards. For example, the further removed non-compliance with laws and regulations (irregularities) is from the events and transactions reflected in the financial statements, the less likely the inherently limited procedures required by auditing standards would identify it. In addition, as with any audit, there remained a higher risk of non-detection of irregularities, as these may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal controls. #### STATUTORY INFORMATION

North London Collegiate School Enterprises Thailand Limited is a Private Company, limited by shares, incorporated in England & Wales, Registration Number 11187640, and wholly owned by North London Collegiate School International Ltd. The company operates the franchise agreement with the NLCS School in Thailand.

#### 1 ACCOUNTING POLICIES

The following accounting policies have been used consistently in dealing with items which are considered material to the company's affairs.

#### (a) Accounting convention

The accounts have been prepared in accordance with applicable UK accounting standards with the provision of FRS 102 Section 1A small entities and comply with Companies Act 2006. The financial statements have been prepared under the historical cost convention.

#### (b) Turnover

The company is not currently trading and as such it does not have any turnover.

#### (c) Allocation of expenditure

Certain of the costs of providing franchising services are allocated annually between North London Collegiate School and the company.

#### (d) Going concern

The accounts have been prepared on a going concern basis because there is continued financial support from NLCS International, the parent entity, for the Company to continue conducting its principal activities of developing franchising activities in Thailand.

#### (e) Judgements and estimates

Income received in respect of set-up costs from our franchising partner has been recognised to the extent that staff costs have been incurred. An area of judgment is the provision made against debtors. There are no other judgements or estimates which materially affect the amounts recognised in these accounts.

#### (e) Cash Flow Statement

The company has taken advantage of the exemption from the requirement to prepare a cash flow statement on the grounds that it qualifies as a small company, as defined by the Company's Act 2006, under FRS 102 1A.

#### (f) Financial Instruments

Basic financial instruments are initially recognised at transaction value and subsequently measured at amortised cost with the exception of investments which are held at fair value. Financial Assets held at amortised cost comprise cash at bank and in hand, together with debtors except prepayments. A specific provision is made for debts for which recoverability is in doubt. Cash at bank and in hand is defined as all cash held in instant access bank accounts and used as working capital. Financial liabilities held at amortised cost comprise all creditors except social security and other taxes, provisions and deferred income. Investments are held at fair value at the balance sheet date, with gains and losses being recognised within income and expenditure.

#### 7 ULTIMATE PARENT COMPANY AND CONTROLLING PARTY

At 31 July 2021 the ultimate parent company and controlling party was The North London Collegiate School, a charitable company incorporated in the United Kingdom. #### 8 RELATED PARTY TRANSACTIONS

The company has taken advantage of the exemption under Financial Reporting Standard 102 para 33.1A not to disclose any transactions with its parent undertaking and other group entities on the basis that it is a wholly owned subsidiary and the company's results for the year are included in the consolidated financial statements of the ultimate parent undertaking.
