PART 1 - GENERAL DESCRIPTION OF THE COMPANY'S ACTIVITIES AND IMPACT

The company runs several activities for local children in Trafford Metropolitan Borough, South Manchester in Greater Manchester as well as running online classes with very low competitive rates, honouring our non-profit status.

We recovered from the pandemic closing and now run two chess clubs: online and offline. We started running chess for primary school age children online and offline with two different coaches, whose skills flourished under our supervision and the Manchester Check Mates club become stronger and bigger. One class in September 2021 grew into two classes, which reduced our waiting list and gave more opportunities for younger children.

Our children participated in several Tournaments: Local Manchester tournaments and National tournaments. Some of our children became such strong players that were chosen to represent Manchester in UK competitions.

What we offer now is unique in South Manchester and is highly regarded among local residents. We are the only local chess club that teaching complete beginners from the age of six.

Modern foreign languages remain popular but still small unprofitable classes. Last year we had a girl achieving grade 9 (highest possible mark) in her Russian Language GCSE. Based on modern theories of teaching and introducing languages, as well as promoting bilingualist, we now teaching children from the age of two.

With the support and help of the local Community Centre, The Hub, we were able to reopen the language classes on Saturdays. Classes are small in size, and we are subsidising it investing our admin time in running it effectively and smoothly.

After the pandemic closing it became apparent that many children needed extra help and we continued with online one-to-one classes for those in need.

We now have 9 volunteer coaches helping children in various subjects: mathematics, chemistry, physics, biology, English language (both as a native language and as a foreign language), computer science.

We encouraged our volunteers to educate themselves through various available training. We sponsor some training as well. All our tutors are aiming to achieve recognisable teaching qualifications. Our chess coach was sponsored and supported by us in becoming a chess arbiter. He now is able to judge all local chess tournaments and championships being fully qualified!

We promoted a culture of support, being a good listening ear and accommodating the needs of those children who kept studying with us. We help and support parents with providing good teaching materials, clear guidance in helping children to succeed and achieve.

We run a New Year party for children and parents. It was a joyful celebration. We had over 50 Trafford residents people attending it.

We feel proud that we were able to create a learning community and support families through hardships. We have plans to open classes for children gifted in mathematics from underprivileged background in 2023.
