As COVID-19 hit, EmpowrU had to change its approach and set up working remotely and virtually alongside food hubs to help support vulnerable groups. We received funding from West Midlands VRU, which was aimed at reducing violence amongst young people in hard to reach areas. Many schools began to ask for additional support as a result. We also received funds from European social Find for an employability project, and increased funding for our SHEWINS project which enabled girls across coventry to improve their health, wellbeing and aspirations.
