Airborne Allergy Action CIC was set up to raise awareness of the importance of environmental allergen avoidance (alongside prescribed medication) in the home, schools and other places that children spend extended periods of time. It provides benefit in particular to children in Lewisham and surrounding London boroughs, but also nationally, who are suffering from asthma and other allergy related illness caused by environmental allergens (eg. dust mites, indoor and outdoor moulds, tree pollen (particularly birch, hazel and alder), grass pollen & animal dander.)

During the period the company set up a website to raise awareness of the relevant issues and a Facebook group to share tips with stakeholders on the most effective methods of inhaled allergen avoidance. There have been many reported benefits in improved health of children as a result of undertaking such avoidance.
