Airborne Allergy Action C.I.C. raises awareness of the importance of environmental allergen avoidance (alongside prescribed medication) in the home, schools and other places that children spend extended periods of time. This provides health benefits in particular to children in Lewisham and surrounding London boroughs, but also nationally, who are suffering from asthma and other allergy related illness caused by environmental allergens (eg. dust mites, indoor and outdoor moulds, tree pollen (particularly birch, hazel and alder), grass pollen & animal dander as well as those caused by high Particulate Matter and viruses.

During the period the Company continued to raise awareness through its Facebook group, distributing STEM Junior indoor Air Quality packs produced by the Indoor Air Quality Working Party to children and schools, attending meetings associated with the UKRI Strategic Priorities Fund Clean Air networks, attending meetings of the Wellhome (West London Healthy Home and Environment Study) Project and showing affected parents how to reduce the risk of asthma and other illness by inhaled allergen avoidance alongside prescribed medication with associated health benefits. A demonstration video of building a Corsi Rosenthal hepa air cleaner was also co-produced with CleanAir Classrooms and the Ella Roberta Foundation with a view to help schools to build these.
