### **Business review**

The Company was established to hold investments as nominee on behalf of the Limited Partnerships DHIV.1 No 1 LP, DHIV.1 No 2 LP and DHIV.1 EZ LP of which the Company's parent undertaking, DH IV.1 Managing GP Limited is the managing General Partner.
