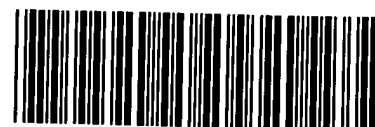

Songhaven Community Interest Company has continued to deliver dementia-friendly music events in the 2021-22 financial year including:

- **Songhaven Concert Series** at St Paul's Knightsbridge and Lumen URC in London
- **Songhaven Care Concert** visits by professional singers to residential care homes
- **Bespoke special events** (e.g. opera galas, outdoor concerts, and live-streams) in collaboration with care homes, community centres, and other organisations.
- The free online **Songhaven at Home** concert films

All our offerings are designed to benefit the community, providing regular opportunities for people living with dementia to enjoy professional music from classically-trained artists, and provide paid performance opportunities for performers.

There is a wealth of scientific evidence linking music (and particularly singing) to improvements in mood, social engagement, and decreased agitation which can lead to better appetites and sleep quality, as well as cognitive benefits. Songhaven audience members, their companions/carers, and care home staff have themselves observed and reported several of the above benefits. Companions and family members have also appreciated the dignified, professional quality of the events - noting that they can also free themselves from the stresses of their roles, and feel part of a community where their loved one/client is encouraged to sing along and respond to the music freely without stigma or shame. Our work has been vitally important to our audience as we eased out of lockdown, when feelings of stress and anxiety from the pandemic were still being felt.
