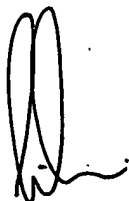
## **STRATEGIC REPORT**

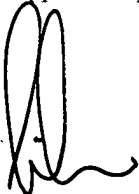

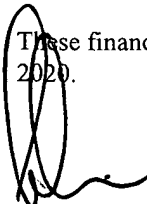
