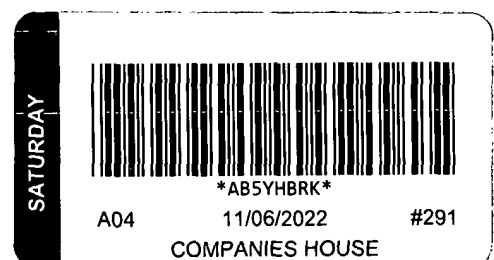

**1 Statutory information**

**2 Average number of employees**
