

Written Resolutions of

Pocket Change Pioneers Ltd

Company Number 11588402 (the "Company")

4 August 2023 (the "Circulation Date")

Pursuant to Part 13, Chapter 2 of the Companies Act 2006 (the "Act"), the undersigned being the eligible members (as defined in section 289 of the Act) hereby approve and pass the following written resolutions (each a "Resolution" and, together, the "Resolutions"), in the case of Resolution 1 as an ordinary resolution and, in the case of Resolution 2, as a special resolution of the Company and agree that these Resolutions will for all purposes be valid and effective as if they had been passed at a general meeting of the Company duly convened and held.

ORDINARY RESOLUTION

1. **THAT**, subject to and simultaneous with the passing of Resolution 2, in accordance with section 551 of the Act, the directors of the Company be generally and unconditionally authorised to allot shares in the Company so that the entire share capital of the Company will be increased by no more than 232,876 ordinary shares of £0.0002 each in the capital of the Company.

This authority will, unless renewed, varied or revoked by the Company, expire five years from the passing of this Resolution save that the Company may, before such expiry, make an offer or agreement which would or might require shares to be allotted and the directors may allot shares in pursuance of such offer or agreement notwithstanding that the authority conferred by this Resolution has expired.

For the avoidance of doubt, this authority is supplemental to any subsisting section 551 authority.

SPECIAL RESOLUTION

2. **THAT**, subject to and simultaneous with the passing of Resolution 1, any and all preemption rights to which the shareholders of the Company may be entitled, howsoever arising (including but not limited to under the Company's articles of association from time to time or the Act) in respect of the allotment and issue of shares made by the directors pursuant to the authority conferred upon them by Resolution 1 above be and hereby are waived or otherwise disapplied.
