

Blue Bear Coffee Co., the trading name of The Justice Business CIC, had a great first year of trading. The vast majority of our sales came through the website (www.bluebearcoffee.com), which didn't launch until 31st January 2019.

Our investment in keep cups paid dividends with 132 units sold.

Our 220g retail coffee selection also proved popular, with 690 units sold.

Our 1kg bags, which were sold to retail and wholesale customers alike totalled 588 units.

With every bag of coffee sent to a customer we included a postcard which introduced them to the issue of human trafficking and the amazing charities we support.

We were also able to reach over 1600 followers on social media platforms and keep over 150 subscribers up to date with a monthly newsletter.

I (Bryn Frere-Smith, Founder) was able to talk to a number of churches, businesses and listeners to BBC Radio Norfolk / The Together Podcast / The Last Supper Podcast — about the issues of human trafficking and modern-day slavery. Our story was also covered in the Independent Newspaper and the Easter Daily Press.

At the close of the year we had planned and invited a number of guests to appear on our very own podcast, which launched in September 2019, where individuals were invited on to share their stories of fighting injustice, over a cup of coffee.

The story of Blue Bear was also adopted by a small South Wales charity called the Red Community which consequently turned it into a children's story book called Brave, which is now being read in schools across the United Kingdom.
