**REPORT OF THE DIRECTOR
FOR THE YEAR ENDED 31 OCTOBER 2021**

The director presents her report with the financial statements of the company for the year ended 31 October 2021.

DIRECTOR

S C Hospital held office during the whole of the period from 1 November 2020 to the date of this report.

GOING CONCERN

Management continues to review the SPV's position and will take action to protect its capital position as appropriate. With limited balance sheet exposure to market volatility, the company is mostly exposed to risk from slow or depressed trading conditions for the entity into which funds are invested.

The going concern status of OneRagtime Antescofo Ltd is entirely dependent on the financial performance of the company in which it has placed its investment, shown at note six of these financial statements.

Having reviewed budgets and cashflow forecasts of the investee company the director remains confident that the going concern status of the investee company remains appropriate. Despite these uncertainties the director has no intention of changing the current investment strategy. The director therefore considers the going concern basis of preparation to be appropriate.

STATEMENT OF DIRECTOR'S RESPONSIBILITIES

The director is responsible for preparing the Report of the Director and the financial statements in accordance with applicable law and regulations.

Opinion

We have audited the financial statements of Oneragtime Antescofo Limited (the 'company') for the year ended 31 October 2021 which comprise the Profit and loss account, Other Comprehensive Income, Balance Sheet, Statement of Changes in Equity, Cash Flow Statement and Notes to the Cash Flow Statement, Notes to the Financial Statements, including a summary of significant accounting policies. The financial reporting framework that has been applied in their preparation is applicable law and United Kingdom Accounting Standards, including Financial Reporting Standard 102 'The Financial Reporting Standard applicable in the UK and Republic of Ireland' (United Kingdom Generally Accepted Accounting Practice).

We evaluated the director's and managements incentives and opportunities for fraudulent manipulation of the financial statements (including management override of controls) and determined the principal risks were related to the miss appropriation of investor funds, management bias through application of judgement and assumptions in significant accounting estimates particularly relating to the recoverable amount of the fixed asset investment.

1. STATUTORY INFORMATION

2. STATEMENT OF COMPLIANCE

These financial statements have been prepared in accordance with Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" and the Companies Act 2006.

3. ACCOUNTING POLICIES

Basis of preparing the financial statements

The financial statements have been prepared on the historical cost basis.

Despite the current uncertainties arising from Corona Virus, the director has assessed the recoverable amount of the fixed asset investment shown at note six through reviewing cashflow forecasts of the investee company and remains confident in the success of this company and considers the going concern basis of preparation to be appropriate and therefore the investment strategy remains unchanged.

Revenue recognition

Turnover is recognised in respect of management fees recharging professional fees incurred during the year under review.

Going concern

Investments

Where possible, equity investments will be valued in accordance with IPEVC (International Private Equity & Venture Capital) Valuation Guidelines, otherwise they will be valued at cost less impairment. As the investee companies that the fund has invested into are not listed the valuation would be based on the last issued share price. Where investments are revalued upwards they do not take into account any performance fee costs recognised against the investment.

3. ACCOUNTING POLICIES - continued**Impairment of fixed assets**

At each reporting period end date, the company reviews the carrying amounts of its fixed asset investments to determine whether there is any indication that those assets have suffered an impairment loss. If any such indication exists, the recoverable amount of the asset is estimated in order to determine the extent of the impairment loss (if any). Where it is not possible to estimate the recoverable amount of an individual asset, the company estimates the recoverable amount of the cash-generating unit to which the asset belongs.

Recoverable amount is the higher of fair value less costs to sell and value in use. In assessing value in use, the estimated future cash flows are discounted to their present value using a pre-tax discount rate that reflects current market assessments of the time value of money and the risks specific to the asset for which the estimates of future cash flows have not been adjusted.

If the recoverable amount of an asset (or cash-generating unit) is estimated to be less than its carrying amount, the carrying amount of the asset (or cash-generating unit) is reduced to its recoverable amount. An impairment loss is recognised immediately in profit or loss, unless the relevant asset is carried at a revalued amount, in which case the impairment loss is treated as a revaluation decrease.
