

### WRITTEN RESOLUTIONS

Pursuant to Chapter 2 of Part 13 of the Companies Act 2006 (the "Act"), the directors of the Company propose that resolution 1 and 2 below be passed as special resolutions (the "Resolutions").

## **Special Resolutions**

- **2** THAT, in accordance with section 21(1) of the Act, the articles of association of the Company be amended by inserting new definitions in article 1.1 as follows:
  - "Fair Value: The Fair Value shall be the price per Sale Share determined by the Independent Expert on the following bases and assumptions:
    - (a) valuing the Sale Shares as on an arm's-length sale between a willing seller and a willing buyer as at the date the Transfer Notice was served (or deemed served);
    - (b) if the Company is then carrying on business as a going concern, on the assumption that it will continue to do so;
    - (a) that the Sale Shares are capable of being transferred without restriction;
    - (b) valuing the Sale Shares as a rateable proportion of the total value of all the issued Shares without any premium or discount being attributable to the percentage of the issued share capital of the Company which they represent; and

- (c) reflecting any other factors which the Independent Expert reasonably believes should be taken into account.
- Independent Expert: the accountants for the time being of the Company or, if they
  decline the instruction, an independent firm of chartered accountants of repute
  appointed by the Company and the Seller or failing agreement within 10 Business
  Days, appointed by the president of the Institute of Chartered Accountants of
  England and Wales."
