ARTICLES OF ASSOCIATION

OF

ISM NEWCO LIMITED

DEFINITIONS AND INTERPRETATION

- 1. The following definitions and rules of interpretation apply in these Articles:
 - "Articles" means the Company's articles of association for the time being in force;
 - "Company" means ISM NewCo Limited;
 - "Model Articles" means the model articles for private companies limited by guarantee contained in Schedule 2 of the Companies (Model Articles) Regulations 2008 (SI 2008/3229) as amended prior to the date of adoption of these Articles.
- 2. Headings in these Articles are used for convenience only and shall not affect the construction or interpretation of these Articles.

MODEL ARTICLES

3. The Model Articles shall apply to the Company except in so far as they are modified or excluded by or are inconsistent with these Articles.

DIRECTORS TO TAKE DECISIONS COLLECTIVELY

- 4. Model Article 7 shall be amended by:
 - (a) the insertion of the words "for the time being" at the end of Model Article 7(2)(a); and
 - (b) the insertion in Model Article 7(2) of the words "(for so long as he remains the sole director)" after the words "and the director may".

UNANIMOUS DECISIONS

5. Model Article 8(2) shall be deleted and replaced by the words "Such a decision may take the form of a resolution in writing, where each eligible director has signed one or more copies of it, or to which each eligible director has otherwise indicated agreement in writing."

CONFLICTS OF INTEREST

6. Model Article 14 shall not apply to the Company.

TERMINATION OF MEMBERSHIP

7. Model Article 22(1) shall be amended by the deletion of the words "7 days".

RULES

8. The directors may establish rules governing matters relating to Company administration that are required from time to time for the effective operation of the Company (for example, the provisions relating to classes of members, membership fees and subscriptions and the admission criteria for members). If there is a conflict between the terms of these Articles and any rules established under this Article, the terms of these Articles shall prevail.
