## NOTES TO THE FINANCIAL STATEMENTS for the Year Ended 31 JANUARY 2021

### 1. STATUTORY INFORMATION

Naturewise Eco Shop CIC is a private company, limited by shares, registered in England and Wales. The company's registered number and registered office address can be found on the Company Information page.

### 2. ACCOUNTING POLICIES

#### Basis of preparing the financial statements

These financial statements have been prepared in accordance with Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" including the provisions of Section 1A "Small Entities" and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

#### Turnover

Turnover is measured at the fair value of the consideration received or receivable, excluding discounts, rebates, value added tax and other sales taxes.

#### Stocks

Stocks are valued at the lower of cost and net realisable value, after making due allowance for obsolete and slow moving items.

#### Taxation

Taxation for the year comprises current and deferred tax. Tax is recognised in the Income Statement, except to the extent that it relates to items recognised in other comprehensive income or directly in equity.

Current or deferred taxation assets and liabilities are not discounted.

Current tax is recognised at the amount of tax payable using the tax rates and laws that have been enacted or substantively enacted by the balance sheet date.

#### Deferred tax

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.

Timing differences arise from the inclusion of income and expenses in tax assessments in periods different from those in which they are recognised in financial statements. Deferred tax is measured using tax rates and laws that have been enacted or substantively enacted by the year end and that are expected to apply to the reversal of the timing difference.

Unrelieved tax losses and other deferred tax assets are recognised only to the extent that it is probable that they will be recovered against the reversal of deferred tax liabilities or other future taxable profits.

This year was a doubly difficult one for us. Apart from the restrictions and anxieties of the pandemic, we sadly lost Alpay Torgut in January 2020. Alpay was founder, inspiration and day-to-day co-ordinator of the Eco Shop and a prime mover in our sister organisation, Naturewise Forest Garden.

His loss was sorely felt at many levels. However, we did manage to reorganise and carry on. We now have a new co-ordinator who has been able to make the shop safe for Covid and hold everything together through challenging times.

On the plus side, we learned something truly heartening at the end of the first period of lockdown. We discovered the loyalty of our regular customers and had it confirmed that the majority of our support does come from the local area. Customers were pleased to see us back. In the almost complete absence of visitors to Cardigan during the year, we have seen just how strong our connection to local people has become.

There had been concerns that, once the initial lockdown ended, most of the volunteers would have moved on. It was encouraging to find out that most of them returned and new ones came forward.

Despite being closed for half the year and returning after lockdown with shorter hours, we have continued to sell donated goods, refurbished tools and some locally made work. Our turnover is significantly down on last year, but so have been our hours open and the ability of people to get to the shop and to bring us donations.

We were able to make a small grant to the Forest Garden during the year towards their operating costs. We are holding reserves for them for future growth. We continue to have a display board explaining our connection to the garden.

It has not been possible to create new displays in the shop on sustainable living. In order to make the shop safer, a one-way system is needed and this has reduced the spare space. Also, keeping the shop going has taken up the time and energy of both our co-ordinator and the volunteers with little left over for pursuing this part of our aims as a CIC. Hopefully, we can put our minds to this in future.




