## Directors' indemnity

#### **Dividends**

The company has not declared any dividends during the year (2020 \$0). The directors do not propose the payment of a dividend.

There is no post balance sheet event at the reporting date for the entity.

# Going concern

The directors consider it appropriate to adopt the going concern basis of accounting in preparing the financial statements. The current economic and geopolitical environment, as well as the ongoing impact of COVID 19 were considered as part of the going concern assessment.

Liquidity and financing is managed within the bp Group under pooled group-wide arrangements which include the company. As part of the going concern basis of preparation for the company, the ability and intent of the bp group to support the company has also been taken into consideration. The most recent bp group financial statements continue to be prepared on a going concern basis. Forecast liquidity of the bp group has been assessed under a number of stressed scenarios, including a significant decline in oil prices over the 12-month period from the date these financial statements were approved. Reverse stress tests performed indicated that the bp group will continue to operate as a going concern for at least 12 months from the date of approval of the financial statements even if the Brent price fell to zero. In addition, bp group management have confirmed the existing intra-group funding and liquidity arrangements as currently constituted are expected to be maintained for the foreseeable future, being no less than twelve months from the approval of these financial statements. No material uncertainties over going concern or significant judgements or estimates on the assessment were identified. Accordingly, the company will be able to draw on support from the bp group for the foreseeable future and these financial statements have therefore been prepared on a going concern basis.

In assessing the prospects of BP Exploration (D230) Limited, the directors noted that such assessment is subject to a degree of uncertainty that can be expected to increase looking out over time and, accordingly, that future outcomes cannot be guaranteed or predicted with certainty.

Having a reasonable expectation that the company has adequate resources to continue in operational existence for at least the next 12 months from the date these financial statements were approved, the directors consider it appropriate to continue to adopt the going concern basis of accounting in preparing the financial statements.

### **Future developments**

The directors believe that the company is in a good position to take advantage of any opportunities which may arise in the future.

It is the intention of the directors that the business of the company will continue for the foreseeable future.

#### Financial risk management

The company is exposed to a number of different financial risks arising from natural business exposures as well as its use of financial instruments including market risks relating to commodity prices, foreign currency exchange rates and interest rates; credit risk; and liquidity risk. 1. Authorization of financial statements and statement of compliance with Financial Reporting Standard 101 Reduced Disclosure Framework (FRS 101)

The financial statements of BP Exploration (D230) Limited for the year ended 31 December 2021 were approved by the board of directors on 29/09/2022 and the balance sheet was signed on the board's behalf by J Freeman. BP Exploration (D230) Limited is a private company, limited by shares incorporated, domiciled and registered in England and Wales (registered number 11796185). The company's registered office is at Chertsey Road, Sunbury on Thames, Middlesex, TW16 7BP, United Kingdom. These financial statements were prepared in accordance with Financial Reporting Standard 101 'Reduced Disclosure Framework' (FRS 101) and the provisions of the Companies Act 2006.

#### Principal activity

The State Oil Company of the Azerbaijan Republic ("SOCAR") and BP Exploration (Azerbaijan) Limited have executed an EDPSA for the joint exploration and development of Block D230 in the Azerbaijan Sector of the Caspian Sea dated 26 April 2018, and which became effective on 1 December 2018. Block D230 lies some 135 kilometres (84 miles) north-east of Baku in the Caspian Sea. It covers an area of some 3,200 square kilometres and has not previously been explored. It has water depths of 400-600 metres and anticipated reservoir depths of about 3,500 metres.

The Initial Exploration Period ("IEP") commenced on the effective date of the EDPSA (1 December 2018) and will last until the date immediately following (i) a period of twenty-four (24) months from the effective date, or (ii) the date of submission to SOCAR of a Notice of Prospectivity whereby bp has the right to select up to 3 prospective areas to be further explored, whichever is earlier. During the IEP, bp will acquire seismic data, complete data interpretation and carry out prospect evaluation. Immediately following the date of the Notice of Prospectivity, the EDPSA will progress into the Main Exploration Period ("MEP"), which will last for a period of 3 years (with a possibility to extend further). During the MEP, bp will focus on planning and execution of exploration wells in the selected prospective areas.

The EDPSA was originally executed by BP Exploration (Azerbaijan) Limited ("BPXA"). BP D230 Limited ("BP D230") was incorporated on 10 December 2018 and on 1 October 2019 it assumed the entire participating interest, together with all rights, obligations and liabilities, of BPXA with regard to the EDPSA. As a contractor party, BP D230 has a 50% participating interest under the EDPSA. The remaining 50% participating interest is held by SOCAR Oil Affiliate ("SOA"), a company to be formed, owned and controlled by SOCAR. Pending formation of SOA, all rights and obligations of SOA will be performed by SOCAR.

On 30 December 2020 bp executed a joint operating agreement ("JOA") with SOCAR Oil Affiliate ("SOA"), which provides for joint venture governance details and structure as well as precise definition of rights and responsibilities of the contractor parties to the EDPSA. According to the terms of the EDPSA, bp or its affiliate shall act as the operating company during IEP and MEP, and before SOCAR's approval of the first development programme. Upon approval of the first development programme, bp and SOA shall establish a joint operating company (JOC) equally owned by bp and SOA. On 29 January 2019 the company has been incorporated to act as the operating company under the EDPSA during the IEP and MEP, and will be appointed as such upon execution of the JOA.

Under the EDPSA, the operating company is entitled to all the benefits, waivers, indemnities and exemptions awarded to the interest holders (contractor parties). However, the operating company shall only act as operator upon instructions from the contractor parties, it shall own no assets or equipment, shall not be entitled to any share of petroleum produced nor shall it make a profit or loss.

# Principal activity (continued)

The operating company shall record all financial flows or other transactions of the interest holders as passing through to the contractor parties as though it did not exist as a commercial entity, and for all purposes the amount of its taxable profit shall be nil.

In 2019, bp commenced exploration activity in the D-230 Block offshore Azerbaijan. A contract was signed between bp and Caspian Geo LLC in April 2019 for the acquisition of 3D seismic data. Caspian Geo mobilised the SOCAR-owned MV Gilavar seismic vessel in September 2018 and after completion of seismic operations for another Operator in a nearby area, the vessel arrived in the D-230 block on 24th December and commenced seismic data acquisition on 26th December 2019. The survey was completed on 14th March 2020, with demobilisation and D-230 Block exit on 15th March 2020. In total 5,031.7 km of sail-line 3D seismic data acquisition was completed over a surface area of approximately 3,700 sq km. All the field seismic data products were delivered by Caspian Geo directly to bp-Baku on completion of the survey.

After a competitive bid process, the contract for seismic data processing was awarded to CGG-UK in January 2020. A copy of the field seismic data was delivered to the CGG Data Centre in the UK in March 2020. Processing work commenced immediately after data receipt and CGG applied a full technical limit seismic data processing sequence to the D-230 data. The work-flow included 3D de-ghosting, 3D-MWD and 3D-SRME de-multiple, 3D de-noise, 4D interpolation, anisotropic velocity model build and 3D depth imaging. An initial early-out 3D seismic data volume was delivered on 31st August 2020 and final full-processing 3D seismic data products were delivered on 31st November 2020.

bp has fulfilled its obligations under the Initial Exploration Period (seismic acquisition and processing). In accordance with EDPSA, in order to proceed to the Main Exploration Period ("MEP"), bp is required to issue a Notice of Prospectivity by 1 December 2020. However, currently bp is in the process of finding a joint venture partner to make a decision to proceed to the MEP, hence Notice of Prospectivity has not been issued yet. This process is on-going.

# Basis of preparation

These financial statements have been prepared in accordance with FRS 101. The financial statements have been prepared under the historical cost convention. Historical cost is generally based on the fair value of the consideration given in exchange for the assets.

The accounting policies that follow have been consistently applied to all years presented, except where otherwise indicated.

The company meets the definition of a qualifying entity under FRS 100 'Application of Financial Reporting Requirements' issued by the FRC. Accordingly, these financial statements were prepared under the historical cost convention in accordance with Financial Reporting Standard 101 Reduced Disclosure Framework and the Companies Act 2006. As permitted by FRS 101, the company has taken advantage of the disclosure exemptions available under that standard in relation to:

- (a) the requirements of paragraphs 10(d), 10(f), 16, 38A, 38B, 38C, 38D, 40A, 40B, 40C, 40D, 111 and 134 to 136 of IAS 1 Presentation of Financial Statements;
- (b) the requirement in paragraph 38 of IAS 1 Presentation of Financial Statements to present comparative information in respect of: paragraph 79(a)(iv) of IAS 1;
- (c) the requirements of IAS 7 Statement of Cash Flows;
- (d) the requirements of paragraphs 30 and 31 of IAS 8 Accounting Policies, Changes in Accounting Estimates and Errors in relation to standards not yet effective;
- (e) the requirements of paragraph 17 and 18A of IAS 24 Related Party Disclosures;
- (f) the requirements of IAS 24 Related Party Disclosures to disclose related party transactions entered into between two or more members of a group, provided that any subsidiary which is a party to the transaction is wholly owned by such a member;

Where required, equivalent disclosures are given in the group financial statements of BP p.l.c. The group financial statements of BP p.l.c. are available to the public and can be obtained as set out in Note 14.

The financial statements are presented in US dollars and all values are rounded to the nearest whole number in dollars (\$).

# Significant accounting policies: use of judgements, estimates and assumptions

In assessing the prospects of BP Exploration (D230) Limited, the directors noted that such assessment is subject to a degree of uncertainty that can be expected to increase looking out over time and, accordingly, that future outcomes cannot be guaranteed or predicted with certainty.

Having a reasonable expectation that the company has adequate resources to continue in operational existence for at least the next 12 months from the date these financial statements were approved, the directors consider it appropriate to continue to adopt the going concern basis of accounting in preparing the financial statements.

# Foreign currency

The functional and presentation currency of the financial statements is US dollars. The functional currency is the currency of the primary economic environment in which an entity operates and is normally the currency in which the entity primarily generates and expends cash.

Transactions in foreign currencies are initially recorded in the functional currency by applying the rate of exchange ruling at the date of the transaction. Where this is not practical and exchange rates do not fluctuate materially the average rate has been used. Monetary assets and liabilities denominated in foreign currencies are retranslated into the functional currency at the spot exchange on the balance sheet date. Any resulting exchange differences are included in the profit and loss account, unless hedge accounting is applied. Non-monetary assets and liabilities, other than those measured at fair value, are not retranslated subsequent to initial recognition.

# Financial assets

Financial assets are recognized initially at fair value, normally being the transaction price. In the case of financial assets not at fair value through profit or loss, directly attributable transaction costs are also included. The subsequent measurement of financial assets depends on their classification, as set out below. The company derecognizes financial assets when the contractual rights to the cash flows expire or the rights to receive cash flows have been transferred to a third party along with either substantially all of the risks and rewards or control of the asset. This includes the derecognition of receivables for which discounting arrangements are entered into.

The company classifies its financial assets as measured at amortized cost or fair value through profit or loss. The classification depends on the business model for managing the financial assets and the contractual cash flow characteristics of the financial asset.

#### Financial assets measured at amortized cost

Financial assets are classified as measured at amortized cost when they are held in a business model the objective of which is to collect contractual cash flows and the contractual cash flows represent solely payments of principal and interest. Such assets are carried at amortized cost. This category of financial assets includes trade and other receivables.

# Impairment of financial assets measured at amortized cost

The company assesses on a forward-looking basis the expected credit losses associated with financial assets classified as measured at amortized cost at each balance sheet date. Expected credit losses are measured based on the maximum contractual period over which the company is exposed to credit risk. As lifetime expected credit losses are recognized for trade receivables and the tenor of substantially all other in-scope financial assets is less than 12 months there is no significant difference between the measurement of 12-month and lifetime expected credit losses for the company. The measurement of expected credit losses is a function of the probability of default, loss given default and exposure at default. The expected credit loss is estimated as the difference between the asset's carrying amount and the present value of the future cash flows the company expects to receive, discounted at the financial asset's original effective interest rate. The carrying amount of the asset is adjusted, with the amount of the impairment gain or loss recognized in the profit and loss account.

A financial asset or group of financial assets classified as measured at amortized cost is considered to be credit-impaired if there is reasonable and supportable evidence that one or more events that have a detrimental impact on the estimated future cash flows of the financial asset (or group of financial assets) have occurred. Financial assets are written off where the company has no reasonable expectation of recovering amounts due.

#### Financial liabilities

The measurement of financial liabilities is as follows:

# Financial liabilities measured at amortized cost

Financial liabilities are initially recognized at fair value, net of directly attributable transaction costs. For interest-bearing loans and borrowings this is typically equivalent to the fair value of the proceeds received net of issue costs associated with the borrowing.

After initial recognition, these financial liabilities are subsequently measured at amortized cost. This category of financial liabilities includes trade and other payables and finance debt.

## Offsetting of financial assets and liabilities

Financial assets and liabilities are presented gross in the balance sheet unless both of the following criteria are met: the company currently has a legally enforceable right to set off the recognized amounts; and the company intends to either settle on a net basis or realize the asset and settle the liability simultaneously. If both of the criteria are met, the amounts are set off and presented net. A right of set off is the company's legal right to settle an amount payable to a creditor by applying against it an amount receivable from the same counterparty. The relevant legal jurisdiction and laws applicable to the relationships between the parties are considered when assessing whether a current legally enforceable right to set off exists.
