Ordinary Resolutions



- 4 "That the remuneration of the Joint Liquidators be payable as a set amount of £3,250 (inc of disbursements) plus VAT without further resolution of the shareholders of the Company and that the Joint Liquidators be authorised to draw such remuneration on account as and when funds permit.
- 5 "That the basis for calculation of Category 2 disbursements incurred by the Joint Liquidators be fixed and payable by reference to the basis for charging as set out in the Client Terms and Conditions and that the Joint Liquidators be authorised to be reimbursed such costs incurred as and when funds permit."
