Hadleigh Park Cycles CIC (HPC) has continued its work to continue the Olympic Legacy at Hadleigh Park. Rentals were buoyant and the availability of e-bikes has proven to be of benefit to those who have not cycled for a while, due to age or illness/fitness. Many customers have gone on to purchase their own bikes after gaining confidence when hiring and have benefitted from advice from HPC about bikes suitable for their needs. HPC continued with its sales and servicing provision, helping many people to obtain good quality cycles and accessories and to have their bikes in good, roadworthy condition.

August 2022 was the 10-year anniversary of the Olympic games, and HPC collaborated with the landowners, The Salvation Army, to provide a range of activities for the local community to celebrate this anniversary. HPC provided a range of led rides (with bike hire where required) around the park for individuals and families. These were free for the users and take up was extremely good. Feedback from this event demonstrated a clear commitment by many customers to return to the park in order to cycle or walk, particularly from those who had no or little knowledge of the facilities on offer before taking part.

A grant was received from Cycling UK's Big Bike Revival (BBR) fund which targeted women's cycling. Women are under-represented in the sport and HPC were able to offer activities along the BBR requirements of fix – learn – ride. These activities were women's coaching, cycle mechanics and led rides, all of which were free to the user. Take up was good, especially for the led rides. Feedback from this identified a strong need for a women's only cycling group in the area, and HPC has committed to kickstart such a group.

1:1 learn to ride lessons have continued to grow in strength, with HPC's increasing reputation as a good and effective centre for cycle lessons has led to a rise in footfall. Take-up for these lessons is no longer just by people from the surrounding areas but also from further afield in Essex, e.g. Chelmsford and Maldon districts. Demand is high and HPC runs at almost 100% take up of available lessons and an estimated 700 – 800 children learnt to ride in these lessons in this financial year. The follow-on course, Ride On! has been popular, with around 50 children improving their cycling skills after learning to ride. 1:1 adult learn to ride and skills improvement/coaching continued on an ad-hoc basis.

HPC also received an Active Travel grant with the aim of teaching all EYFS classes in the Canvey Island area to learn to ride. There are 9 schools in this area, and 8 of them took up the offer from HPC. An average of 85% of EYFS children learnt to ride and feedback from all the participating schools was extremely positive, from schools and parents, with schools requesting the same offer if available for the following year.

HPC continued to with other organisations, such as the Salvation Army and Bar'n'Bus to provide cycling services, including coaching/led rides for people with different needs, such as homeless and disadvantaged youth. Working with special needs schools continued by offering reduced cost bike hire and provision of coaching/ride leaders. Two very successful cycling days were held over the summer holidays at different venues for children who are in receipt of free school meals, funded by the HAF scheme run by Essex County Council.

The main stakeholders are The Salvation Army, who are the landowners at Hadleigh Park; Essex County Council, who lease the park from the Salvation Army; local schools, both mainstream and alternative provision; and customers for our coaching, learn to ride, free events, hirers and those using our cycle servicing provision.

Regular discussions took place between the Salvation Army and Essex County Council to look at use of the park and trails and to see how services can be improved. Feedback from users is shared at these discussions to inform provision. Verbal feedback is always sought from service users and written feedback requested and received from schools involved in the EYFS learn to ride scheme. As a result of the success of the EYFS scheme HPC is actively pursuing the possibility of further grants being made to increase this scheme to more areas. Feedback from women who used the BBR events means that HPC has undertaken to enable a women-only cycling group to be formed.
