## ORDER

**UPON** the award of sequestration of Jason Hector Blain (the "Bankrupt") in the Stirling Sheriff Court on 18 October 2022 (with the relevant date of the sequestration being 17 June 2022) and the recognition of the sequestration in this jurisdiction by order of Insolvency and Companies Court Judge Jones on 17 March 2023 (the "March Order")

AND UPON the Bankrupt having prior to his sequestration owned shares in the Defendant companies, namely Forza Coraggio Limited (company number 10469532), Pronto Coraggio Limited (company number 10469606), Via Coraggio Limited (company number 10469352) and Winston's House Limited (company number 11909534) (collectively the "Shares" and the "Companies" respectively)

**AND UPON** the Shares now vesting beneficially in the Claimant as his trustee in bankruptcy pursuant to the award of sequestration (made under the Bankruptcy (Scotland) Act 2016) and the March Order (made under the Insolvency Act 1986)

**AND UPON** there being no appointed director of any of the Companies save for the Bankrupt, the Claimant requiring registration as owner of the Shares, and the Court concluding that the Claimant's name has been omitted from the Companies' registers in default and without cause

**AND UPON** these proceedings having been served on the Companies at their registered office addresses with a deemed date of service of 7 June 2023

**AND UPON** notice of these proceedings and this hearing having been given to the Bankrupt by email sent on 12 June 2023 to Frank Brumby, a solicitor, at fbrumby@isadoregoldman.com and fbrumby@hcrlaw.com and receipt of that email having been confirmed

**AND UPON** the Court deciding in its discretion to proceed with final determination of these proceedings today notwithstanding that 14-days have not elapsed between the date of service of these proceedings on the Companies and the date of this hearing

**AND UPON** hearing Rowena Page of counsel for the Claimant and no one appearing for the Companies or the Bankrupt

## IT IS ORDERED THAT:-

- 1. Insofar as required, time for service of these proceedings on the Companies be abridged.
- 2. The Registers of Members of the Companies be and hereafter be treated as rectified by striking out the name of Jason Blain therefrom as the holder of the Shares and by inserting in lieu the name of the Claimant (in his capacity

as the Trustee in Bankruptcy of Jason Hector Blain and of c/o BDO LLP, 2 Atlantic Square, 31 York Street, Glasgow G2 8NJ) as the holder of the Shares.

- 3. The Claimant shall give notice of this Order to the Registrar of Companies.
- 4. No order as to costs.

## Service of this order

The Applicant shall serve a sealed copy of this Order on the Respondents. The Court has provided the Applicant with a sealed copy of this Order for service
