

We took part in a series of workshops about fungi and creativity in collaboration with the MRC Centre scientists.

For the University of Exeter feedback report, a detailed assessment of the project's impact was made, including taking feedback from Volunteers who worked on the project, and the analysis of social media response. Feedback will be incorporated into future projects.

Prior to Still Moving's residency and exhibition at the Plough, we ran workshops with school children from Great Torrington College
