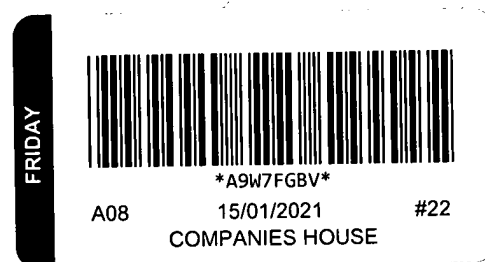

Written Resolution of the members of BEARABLE LTD (the "Company")

Pursuant to chapter 2 of part 13 of the Companies Act 2006 (the "CA 2006"), the following resolution (the "**Resolution**") is proposed by the Directors as a special resolution. The Resolution was first circulated to members of the Company on 9th Jan 2021 (the "**Circulation Date**").

Special resolution

- 1) THAT the Company EMI Share Plan and the Company Unapproved Options Plan, copies of the rules for which are attached to this written resolution, be approved, and the Directors be authorised to do all acts and things necessary to establish the Plans;
- 2) In accordance with section 551 of the CA 2006, the Directors be generally and unconditionally authorised to allot Ordinary shares in the Company up to an aggregate nominal amount of £0.010101 (10,101 shares of £0.000001 nominal value each) under and in accordance with the Plans; and
- 3) In accordance with section 570 of the CA 2006, the Directors be generally empowered to allot equity securities (as defined in section 560 of the CA 2006) pursuant to the authority conferred above, as if section 561(1) of the CA 2006 did not apply to any such allotment, provided that this power shall be limited to the allotment of equity securities up to an aggregate nominal amount of £0.010101 (10,101 Ordinary shares of £0.000001 nominal value each); and
- 4) That any statutory pre-emption rights associated with the allotment of securities pursuant to the authority conferred above should be waived by all Shareholders.
