## STRATEGIC REPORT FOR THE YEAR ENDED 30 JUNE 2023

#### Introduction

The directors present their strategic report and financial statements for the year ended 30 June 2023.

#### **Business review**

JAG UK Holdco Limited is the holding company of JAG UK Bidco Limited.

JAG UK Bidco Limited is the holding entity for the trading subsidiary Junior Adventures Group UK Ltd (previously Energy Kidz Ltd). The Junior Adventures Group brand was launched into the UK following the legal entity restructuring exercise at the end of the prior year. Consequently, Fit For Sport Limited and Sherpa Kids England Ltd were dormant in the year to 30 June 2023. Junior Adventures Group UK Ltd reported turnover of £12.7m (2022: £12.4m for the 3 previously-trading entities combined) and post-tax loss of £0.457m (2022: £1.533m) in the year to 30 June 2023.

Demand for our services again increased steadily throughout the year as more parents returned to the office and settled into new working patterns post-pandemic. Continued nationwide labour shortages led to difficulties in recruiting and retaining employees. Recruitment was a sustained focus for the business and significant sustained investment was made in this area towards the end of the year. Strong improvements were also made with workforce stability (retention & absence) over the course of the year.

The recruitment and people stability difficulties challenged the Group's ability to provide sufficient staff to enable safe operation of our services in the early part of the financial year. This pressure was eased following an exercise to consolidate the business around a lower number of operating settings, before reinstating business development activities towards the end of the year. This, combined with a concerted focus on quality of delivery (including capability of our people and leadership), resulted in an increase in our Ofsted compliance to 94% by the end of the year.

## **Future developments**

JAG UK Holdco Limited, through its indirect trading subsidiaries Junior Adventures Group UK Limited and Pioneer Childcare Ltd continues to follow its strategic objectives of organic attendance growth within existing sites as well as the nationwide launch of new sites as it further entrenches its position as the UK's leading holiday camp and wraparound childcare provider. Operational efficiencies at both a delivery and support office level continue to be a critical focus for the business. High service quality and product delivery remain the cornerstone of the business model.

Where opportunities arise, the Company will seek to acquire other UK providers of camp and wraparound childcare.

No matter or circumstance has arisen since 30 June 2023 that has significantly affected, or may significantly affect the entity's operations, the results of those operations, or the entity's situation in future financial years.

### Principal risks and uncertainties

The Company's operations and that of its trading subsidiaries are subject to a variety of financial and non financial risks. Operational risks are mitigated by comprehensive insurance policies in place within each entity. The key financial risk to the business is cash flow, which is monitored regularly by management and further reviewed in detail as part of the monthly reporting process. Cashflows are carefully managed and when necessary, further funds are available through capital raises and group financial support.

Other than the risks identified above, the directors see minimal risk within this area of the business.

As a simple holding company there are no relevant KPIs for JAG UK Holdco Limited. KPIs are only relevant to the trading entities within the group.

## Opinion

## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 30 JUNE 2023

## 1. General information

JAG UK Holdco Limited is a private company limited by shares incorporated in England and Wales. The registered office is 5A Millars Brook Business Park, Molly Millars Lane, Wokingham, Berkshire, RG41 2AD, England.

Its principal activity was that of an intermediary holding company.

## 2. Accounting policies

## 2.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention unless otherwise specified within these accounting policies and in accordance with Financial Reporting Standard 102, the Financial Reporting Standard applicable in the UK and the Republic of Ireland and the Companies Act 2006.

The financial statements are prepared in pounds sterling, the functional currency, and rounded to the nearest £1.

The company is a parent company of a group. The company is itself a subsidiary company and is exempt from the requirement to prepare group accounts by virtue of Section 401 of the companies Act 2006, as JAG UK Holdco Limited is a subsidiary of Panther Topco Pty Ltd. These financial statements therefore present information about the company as an individual undertaking not about its group.

The preparation of financial statements in compliance with FRS 102 requires the use of certain critical accounting estimates. It also requires management to exercise judgment in applying the Company's accounting policies (see note 3).

The following principal accounting policies have been applied:

## 2.2 Financial Reporting Standard 102 - reduced disclosure exemptions

The Company has taken advantage of the following disclosure exemptions in preparing these financial statements, as permitted by the FRS 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland":

- the requirements of Section 7 Statement of Cash Flows;
- the requirements of Section 3 Financial Statement Presentation paragraph 3.17(d);
- the requirements of Section 11 Financial Instruments paragraphs 11.42, 11.44 to 11.45, 11.47, 11.48(a)(iii), 11.48(a)(iv), 11.48(b) and 11.48(c);
- the requirements of Section 12 Other Financial Instruments paragraphs 12.26 to 12.27, 12.29(a), 12.29(b) and 12.29A;
- the requirements of Section 33 Related Party Disclosures paragraph 33.7.

This information is included in the consolidated financial statements of Panther Topco Pty Ltd as at 30 June 2022 and these financial statements may be obtained from 126-130 Phillip Street, Sydney, New South Wales, Australia.

## 2. Accounting policies (continued)

## 2.3 Going concern

The financial statements have been prepared on a going concern basis. The directors have considered relevant information, including the annual budget, forecast future cash flows and the impact of subsequent events in making their assessment. The going concern of the entity is linked to the going concern of the trading entity Junior Adventures Group UK Ltd. Management have assessed the trading entity as a going concern, so have prepared the holding company accounts also on a going concern basis. Based on these assessments and having regard to the resources available to the entity, the directors have concluded that there is no material uncertainty and that they can continue to adopt the going concern basis in preparing the directors' report and accounts.

#### 2.4 Taxation

Tax is recognised in profit or loss except that a charge attributable to an item of income and expense recognised as other comprehensive income or to an item recognised directly in equity is also recognised in other comprehensive income or directly in equity respectively.

The current income tax charge is calculated on the basis of tax rates and laws that have been enacted or substantively enacted by the balance sheet date in the countries where the Company operates and generates income.

## 2.5 Valuation of investments

Investments in subsidiaries are measured at cost less accumulated impairment.

## 2.6 Debtors

Short-term debtors are measured at transaction price, less any impairment. Loans receivable are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method, less any impairment.

## 2.7 Cash and cash equivalents

Cash is represented by cash in hand and deposits with financial institutions repayable without penalty on notice of not more than 24 hours. Cash equivalents are highly liquid investments that mature in no more than three months from the date of acquisition and that are readily convertible to known amounts of cash with insignificant risk of change in value.

## 2.8 Creditors

Short-term creditors are measured at the transaction price. Other financial liabilities, including bank loans, are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method.

## 2. Accounting policies (continued)

## 2.9 Financial instruments

The Company only enters into basic financial instrument transactions that result in the recognition of financial assets and liabilities like trade and other debtors and creditors, loans from banks and other third parties, loans to related parties and investments in ordinary shares.

#### 3. Judgments in applying accounting policies and key sources of estimation uncertainty

In the application of the company's accounting policies, which are described above, management is required to make judgments, estimates and assumptions about the carrying values of assets and liabilities that are not readily apparent from other sources. The estimates and underlying assumptions are based on historical experience and other factors that are considered to be relevant. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

There are no key sources of estimation uncertainty that have a significant effect on the amounts recognised in the financial statements.
