We are driven by listening to the issue young people today face and through participation and consultation at our community groups or our in schools' projects give young people a safe environment to be listened to. We work in partnership with other organisations and not for profit organisations with the same values and goals to provide opportunities for young people and communities living in Fenland. We have engaged with over 100 young people living in Fenland over the past year and provided access to positive activities through our community sessions and HAF project. Young people have attended activities including roller skating, Bowling, and a 3-day 2 night residential with 40 young people engaging in Team building activities, Climbing, Raft building, Paddle boarding and other outdoor activities. Our social action projects include well-being boxes for young carers. Young people who are involved in community projects and youth support are less likely to engage in criminal and anti-social behaviour, increase self-esteem, increase school attendance and attainment, improve social skills, improve social mobility all of which have a positive impact on the community they live in.
