Bay 20 Community centre remained closed to the public until June 2021. We continued to operate as a Community Kitchen and food bank during this time. Residents were able to come to the centre five days a week for hot meals and twice a week to collect food parcels. Alongside this we also offered an advice and sign-posting service for the local community around monetary and housing.

We work closely with other food banks in the borough and are part of a food network where we meet to discuss the current food poverty levels and discuss ways in which to help alleviate the crisis facing many in the borough. We also share excess food amongst the foodbanks to try to ensure food waste levels remain low.

From June 2021 we started to slowly open for bookings keeping in place covid guidelines as advised by the local council, we reduced our cooking and foodbank to one day a week as other organisations began to re-open and offer food support to the community.

In October 2021 we held our black history month programme which including an outdoor exhibition, music workshops and weekly film show for families and a separate one for adults only. We also had a large outdoor event on a food bank day and had over 350 attendees who benefitted with cooked traditional Caribbean food and entertainment as well as food parcels

We are working closely with WYKD Yoga, Dale Youth Boxing Club, Unity Grove CIC, Kensington and Chelsea Social Council and the Royal Borough of Kensington and Chelsea to introduce classes such as Yoga, Boxing, Tai Chi, Zumba and healthy eating programme. We remain NHS Health partners and sign post on their behalf to local services.

We have throughout the year worked with 900 individuals through the services and projects we have provided in conjunction with our partners, we continue to work with those who have more complex needs.
