PRINCIPAL ACTIVITIES

The company was incorporated on 22 November 2019, and has been dormant throughout the period.

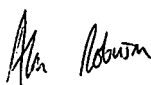

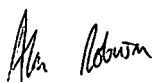

1. ACCOUNTING POLICIES

The principal accounting policies are summarised below. They have all been applied consistently throughout the period.

General information and basis of preparation

The Whitley Neill Distillery Limited is a private limited company limited by shares and is incorporated in England. The address of the registered office is given on page 1. The nature of the company's operations and its principal activities are set out in the Directors report on page 2. The financial statements have been prepared under the historical cost convention and in accordance with applicable law and United Kingdom accounting standards. The functional currency of Br The Whitley Neill Distillery Limited is considered to be pounds sterling because that is the currency of the primary economic environment in which the company operates.

Profit and loss account

No profit and loss account is presented with these financial statements because the company has not received income, incurred expenditure or recognised any other items of comprehensive income during the current financial period. There have been no movements in shareholders' funds during the current financial period and therefore no statement of changes of equity has been included.

Information regarding directors and employees

The company had no employees during the current period.
