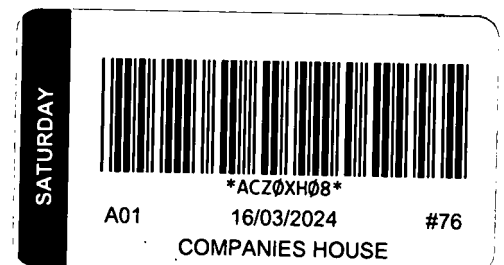

1 Accounting policies

The financial statements have been prepared under the historical cost convention.
