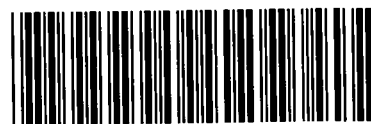

The balance is to be shared between the ordinary, ordinary B and ordinary C shares as set out in article 12.7 and 12.8.
