### IT IS ORDERED that:

- Each of the County Court and hearing centre cases listed in Schedules 1 to 3 hereto ("County Court Cases") (if any) be transferred to the High Court of Justice, Business and Property Courts in Birmingham, Insolvency and Companies List (ChD) for the purpose only of making this Order. Immediately upon this Order taking effect, the County Court Cases be transferred back to the relevant County Court or hearing centre.
- Nigel Morrison ("First Applicant") be removed as officeholder to be replaced by Amanda Wade, Robin Parker, Jonathan Roden and/or Philip Stephenson, as officeholders, as applicable ("Replacement Officeholders"), as set out in paragraphs 3 to 5 below and in Schedules 1 to 3 attached hereto. The consents of the Replacement Officeholders to act are contained in their witness statements.
- The First Applicant be removed from office as Joint Administrator of the companies in Administration listed in Schedule 1 attached hereto with effect from the date of this Order and the individual(s) named as Replacement Officeholder(s) in Schedule 1 be appointed in substitution as Joint Administrator of the said companies with effect from the date of this Order, pursuant to paragraphs 88 and 95 of Schedule B1 of the Insolvency Act 1986 and rules 12.36(2)(b) and 12.37 of the Insolvency (England and Wales) Rules 2016.
