During the financial year 2022-2023, Love Wavertree faced a significant threat to its continuity, primarily due to escalating energy costs and a surge in demand for the food club and referral programme. In response, Love Wavertree Directors sought support from the Steve Morgan Foundation, which granted a crucial £10,000. The foundation's CEO, Liam Eaglestone, acknowledged Love Wavertree's positive impact on the community, underscoring the foundation's joy in backing the organisation. This vital support, coupled with a monthly donation from Virtuopo, enabled Love Wavertree to continue its operations.

Volunteer and Training Development: Acknowledging the indispensable role of the 35 volunteers on our beneficiaries list, Love Wavertree expresses gratitude for their dedicated contributions. Their involvement is pivotal in delivering the various support services that the organisation provides.

Celebrating its second anniversary, Love Wavertree Food Club has made a substantial impact by providing 37,200 food and household items to over 280 registered households in the L15 community. Collaborating with organisations like Fareshare and Feeding Liverpool, the club has significantly alleviated financial strain for local residents. Generous support from Coop Foundation, John Lewis Foundation, Steve Morgan Foundation, Virtuopo, Carolyn Hughes PR, and other contributors has been instrumental in sustaining the Food Club's vital services.

Love Wavertree Micro-grants play a pivotal role in fostering a happier and healthier community in Wavertree. Supported by the profits from the Love Wavertree Community Shop, these micro-grants are a testament to our commitment to transforming old and unloved items into reloved treasures, benefiting the local community. Our impact has been significant, with initiatives receiving over £27,500 in funding. This includes support for in-bloom organisations, junior parkrun, local scouts, schools, football teams, and various resident and community organisations. Additionally, Love Wavertree proudly supported the Lawrence Road Christmas Tree project in partnership with Wavertree Christmas Trees. We extended a £500 grant to Maitri, a Picton Road-based CIC focused on providing crucial health and wellbeing support. This grant empowers Maitri to expand their programmes and offer vital services to individuals grappling with the aftermath of the pandemic and the increasing cost of living. Recognising the dedication of the Friends of Botanic Park, Love Wavertree awarded a £500 grant to assist in acquiring essential tools for their litter-picking efforts within the park. Another £500 grant was bestowed upon Penny Lane Wombles, a volunteer-led community group passionately dedicated to maintaining the cleanliness of South Liverpool's streets and green spaces through ongoing litter-picking projects. Love Wavertree continues its sponsorship of Leighbridge JFC, contributing to their participation in the Edge Hill league. Having sponsored the team in the 2021-2022 and 2022-2023 football seasons, we are

proud to announce our continued support in the upcoming 2023-2024 season. Love Wavertree remains dedicated to nurturing local initiatives that enhance the vibrancy and well-being of our community.

Partnerships and Collaborations: Through partnerships with Merseyside Recycling and Waste Authority, Africa Oye, and the DBS, Love Wavertree has extended its reach and impact. The collaboration with DBS involves staff volunteering days at the Love Wavertree Community Shop, contributing to the community's well-being. The Uniform Hub initiative, supported by Mersey Waste and Recycling Authority, exemplifies sustainable practices, accepting and reselling donated school uniforms to fund Love Wavertree's Food Club.

We regularly hold community meetings and surveys to directly involve community members and volunteers in the decision-making process. Open communication channels, such as social media platforms, are used to keep stakeholders informed and gather their opinions on ongoing projects and initiatives. In response to stakeholder feedback, Love Wavertree has taken several actions to address community needs and concerns.

For instance, the consultation process has led to the initiation of new projects such as recruiting staff, continuing with the Food Club, continuing with the Micro-grants programme, and pausing other projects. We regularly adjust our operations based on feedback from volunteers, ensuring their roles align with their capabilities and availability. The success of the Lawrence Road Christmas Tree project with the school and ongoing support for initiatives like Maitri and Penny Lane Wombles reflect the responsiveness of Love Wavertree to stakeholder feedback from local partners. In summary, Love Wavertree places a strong emphasis on engaging with its stakeholders through various consultation methods, and the company actively takes steps to address the feedback received. We applied for a national lottery grant during the year, and although unsuccessful, the feedback we received said, 'Love Wavertree is clearly embedded in the local community and has a strong track record of community engagement.
