#### Notes to the statement of affairs

#### General

- The book values of the tangible assets have been mainly sourced from the Company's financial statements to 30 June 2021 and depreciated at the appropriate rate. The current asset book values have been taken from the Company's management accounts as at 28 February 2022.
- The costs of any restructuring process have not been taken into account in preparing the ESOA.

#### 1. Assets

Peter Davies FRSA FNAVA, of PDS Valuers and Auctioneers, Maple House, High Street, Potters Bar, EN6 5BS ("PDS") were instructed to undertake a valuation of the assets of the Company.

The estimated to realise values provided are the values that PDS consider the assets would attract on a forced sale ex-situ basis. Any realisations to a willing-purchaser may attract a higher consideration.

#### 2. Debtors

A conservative estimated to realise value has been attributed to the debtor ledger due to the difficulties in collecting book debts in a liquidation scenario.

#### 3. Rent Deposit

It is anticipated that the landlord will retain an element of the rent deposit in order to offset against rent arrears and other claims. Therefore, it is uncertain as to the quantum of the rent deposit, which will be available. It will be for the appointed liquidator to review the position and seek to recover the rent deposit for the benefit of the liquidation estate.

#### 4. Prepayments

This amount represents capital expenditure on a promotional video for the Company. It is not anticipated that this will have any realisable value. However, it will be for the appointed liquidator to investigate this further.

#### 5. Cash at Bank

The sum of £15,041 was held in the Company's bank account with Wise Bank as at 20 April 2022.

#### 6. Cash Held on Appointment

The sum of £12,000 is being held in a Begbies client account pending the appointment of Joint Liquidators. These funds were remitted by the Company to meet the costs of the "Statement of Affairs" fee, which relates to the professional services provided by Begbies in connection with the preparation of the ESOA, the report to creditors and general matters pertaining to the instigation of the winding up proceedings from instruction to the date of the meetings.

#### Preferential creditors

The claims of the Department for Business, Energy and Industrial Strategy represent employees' estimated claims under The Employment Rights Act 1996 in respect of arrears of pay to a maximum of £800 per employee and holiday pay which are claimed preferentially, and pay in lieu of notice, redundancy pay and arrears of pay in excess of £800 which are unsecured.

Employees preferential claims, which include outstanding wages and holidays and pension are estimated in the sum of £18,302.

#### Secondary preferential creditors

The Finance Act 2020 which took effect from 1 December 2020, has given HM Revenue & Customs, ("HMRC") a secondary preferential claim in insolvencies. This secondary preferential status will enable HMRC to be paid in priority to the floating charge holder and the general unsecured creditors in respect of certain taxes owed by the business to HMRC. These taxes include VAT, PAYE, Income Tax, Employee National Insurance Contributions, Student loan deductions and Construction Industry Scheme deductions.

In this case, the apportionment of HMRC's claim which will rank as secondary preferential includes PAYE and employee's NI. The employee's NI figure has been estimated for the purposes of producing the Statement of Affairs.

It is not considered that the Company owes any VAT.

Estimated deficiency as regards Members

Creditors' claims are subject to agreement by the Liquidator and will not be prejudiced by omission from the Statement of Affairs or by inclusion in a different amount from that claimed.

The estimated total deficiency is subject to the costs of winding up for which no provision is made in the statement of affairs.

Material transactions conducted within the previous 12 months other than in the ordinary course of business

Best practice requires disclosure of any material transactions (other than in the ordinary course of business) within the previous 12 months. There have been no such transactions during the course of the last 12 months.

Potential claim for wrongful dismissal

There may be a claim by one of the former employees for wrongful dismissal. It will be for the appointed Liquidator to deal with this claim in due course.
