Circulo C.I.C. exists to work with small businesses in the Peckham area to make them more sustainable and reduce their impact on the local environment and community through collaborative working. In order to fund our community projects we deliver paid sustainability consultancy and advice to businesses. In the year ending 31st July 2021 we were dormant until 1st April when we took on our first consultancy project advising design studio Special Projects on the material impacts of their designs and advising accordingly.

In the same year we have continued to deliver our flagship project: Plastic Free Peckham which works with schools, small businesses and local community groups to reduce their reliance on single-use plastic. We have delivered a talk for the local Scouts group, worked with three local businesses to reduce their single-use plastic and delivered four community clean up events in local green spaces providing volunteering opportunities for 100 members of the local community. We have also started fundraising for our next community project: Sustainable Peckham. This project will see us working more broadly on local issues such as waste, air quality and carbon emissions, working with local businesses to collaborate and find solutions to these local problems. This work will commence in January 2022.

We seek feedback and lessons learned from our paying clients and incorporate this learning into new projects.

Feedback from local small businesses about our work and future plans has also been very positive with many supporting our fundraising activities.
