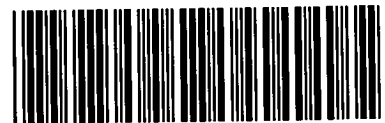

2 Average number of employees


During the period the average number of employees was 2 (2021: 2).
