1. **STATUTORY INFORMATION**

Greene's Tutorial Education Limited is a private company, limited by shares, registered in England and Wales. The company's registered number and registered office address can be found on the Company Information page.

The presentation currency of the financial statements is the Pound Sterling (£).

2. **ACCOUNTING POLICIES**

**Basis of preparing the financial statements**

These financial statements have been prepared in accordance with Financial Reporting Standard 102 "The Financial Reporting Standard applicable in the UK and Republic of Ireland" including the provisions of Section 1A "Small Entities" and the Companies Act 2006. The financial statements have been prepared under the historical cost convention.

**Going concern**

The company incurred a loss before tax of £25K during the year, and had a net liabilities of £68K at the year ended 31 August 2022. There is no indication that the company is making profit in a short period. The company's UK parent has confirmed to financially support the company for at least 18 months from the date of signing these financial statements. Based on this, the director has concluded that the company has adequate resources to continue in operational existence for the foreseeable future. The company therefore continues to adopt the going concern basis in preparing its financial statements.

**Intangible assets**

Intangible assets are initially measured at cost. After initial recognition, intangible assets are measured at cost less any accumulated amortisation and any accumulated impairment losses.

An impairment loss has been recognised in the Income Statement, following an assessment at the Balance Sheet date indicating the recoverable amount was less than its carrying value.

**Tangible fixed assets**

Depreciation is provided at the following annual rates in order to write off each asset over its estimated useful life.

**Financial instruments**

The company has elected to apply the provisions of Section 11 'Basic Financial Instruments' to all of its financial instruments.

Financial instruments are recognised when the company becomes party to the contractual provisions of the instrument.

Financial assets and liabilities are offset, with the net amounts presented in the financial statements, when there is a legally enforceable right to set off the recognised amounts and there is an intention to settle on a net basis or to realise the asset and settle the liability simultaneously.

**Basic financial assets**

Basic financial assets, which include trade and other receivables and cash and bank balances, are initially measured at transaction price including transaction costs and are subsequently carried at amortised cost using the effective interest method unless the arrangement constitutes a financing transaction, where the financial asset is measured at the present value of the future receipts discounted at a market rate of interest.

**Classification of financial liabilities**

Financial liabilities and equity instruments are classified according to the substance of the contractual arrangements entered into. An equity instrument is any contract that evidences a residual interest in the assets of the company after deducting all of its liabilities.

**Basic financial liabilities**

Basic financial liabilities, including trade and other payables, and loans from group undertakings, are initially recognised at transaction price unless the arrangement constitutes a financing transaction, where the debt instrument is measured at the present value of the future payments discounted at a market rate of interest.

Debt instruments are subsequently carried at amortised cost, using the effective interest method.

**Share capital**

Financial instruments issued by the company are classified as equity only to the extent that they do not meet the definition of a financial liability or financial asset.

The company's ordinary shares are classified as equity instruments.

**Taxation**

Taxation for the year comprises current and deferred tax. Tax is recognised in the Income Statement, except to the extent that it relates to items recognised in other comprehensive income or directly in equity.

Current or deferred taxation assets and liabilities are not discounted.

Current tax is recognised at the amount of tax payable using the tax rates and laws that have been enacted or substantively enacted by the balance sheet date.

**Deferred tax**

Deferred tax is recognised in respect of all timing differences that have originated but not reversed at the balance sheet date.

Timing differences arise from the inclusion of income and expenses in tax assessments in periods different from those in which they are recognised in financial statements. Deferred tax is measured using tax rates and laws that have been enacted or substantively enacted by the year end and that are expected to apply to the reversal of the timing difference.

Unrelieved tax losses and other deferred tax assets are recognised only to the extent that it is probable that they will be recovered against the reversal of deferred tax liabilities or other future taxable profits.

**Interest expenses**

Interest expense is recognised using effective interest rate method. In calculating interest expense, the effective interest rate is applied to the amortised cost of the liability for interest expense.

Amounts owed by group undertakings was a loan made to the company's fellow subsidiary Greene's Tutorial College ("GTC"), is unsecured, loan interest is charged at the end of each financial year, on a daily basis, at a fixed rate of 5% per annum, with a repayment date of 31 December 2025. The interest is payment in kind interest and therefore will be added to the overall lending to GTC until such time that GTC is in a position of reporting profits. During the year, interest income of £29,055 (2021: £nil) was recorded, Note 6.

Amounts owed to group undertakings were a loan from its UK parent company KSI Education Limited, charged against the company's assets. The loan interest is charged at the end of each financial year, on a daily basis, at a fixed rate of 5% per annum, with a repayment date of 31 December 2030. The interest is payment in kind interest and therefore will be added to the overall borrowings until such time that the company is in a position of reporting profits. During the period, interest expense of £35,231 (2021: £19,612) was recorded, Note 7.

Included in other creditors, amount of £54K each from the company's directors Mr C Upton and Mr M Uffindell, are advanced to the company under facility agreements. These loans are secured by charging the company's assets, interest charged at a fixed rate of 5% per annum, with a repayment date of 31 December 2025. The interest is payment in kind interest and therefore will be added to the overall borrowings until such time that the company is in a position of reporting profits. During the period, interest expense of £5,799 (2021: £2,863 ) was recorded, Note 7.
