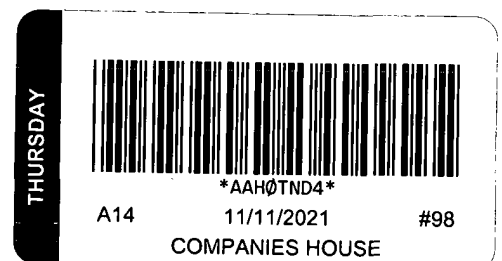

Black Lives in Music is an organisation that is achieving equality for Black musicians and professionals in the music industry through research and advocacy. Black Lives in Music is at the vanguard of the effort to combat racism, uniting organisations and musicians to create a truly inclusive and diverse music industry.

Black Lives in Music supports organisations with diversity training, governance and recruitment; providing mentoring, safe spaces in organisations for musicians and professionals and work with organisations to create pathways for Black people in the music industry.

Black Lives in Music has partnered with forty-five organisations which include orchestras, conservatoires, festivals, venues, sync organisations and more. Over eighty organisations have signed the Black Lives in Music charter.

In 2021 Black Lives in Music commissioned a survey on the personal experience of Black music creators and industry professionals. The survey engaged with nearly 2,000 respondents. The subsequent report now published has produced key information and an insight into the experience of the Black music creators and professionals in today's music industry.

Black Lives in Music campaigns for equity and supports the empowerment of all musicians to realise their aspirations.
