Cousley Wood Fibre Community Interest Company has entered into a contract with Openreach as part of the Cousley Wood Community Fibre Partnership to upgrade the telecommunications network to full fibre-to-the-premises to the benefit of the whole community.

These arrangements are carried out with the benefit of the Government Gigabit Broadband and East Sussex voucher schemes which support the capital costs of the new connections; the company's payment obligations under the contract with Openreach being funded and settled directly by the grants provided under these schemes.

The contract was awarded on 17 December 2020 with a scheduled completion date of the end of 2021.

Openreach have so far installed the infrastructure to the majority of the residents of Cousley Wood, Lower Cousley Wood and surrounding area.

There is one area where problems obtaining landowner's consent was delaying the installation of fibre to these properties. Consent has been granted and we are awaiting completion of the installation by Openreach.

The rest of the infrastructure was tested and commissioned ready for release of the network to the Internet Service Providers on the 31 October 2021.

With the majority of the network available for use, the residents are able to enjoy the improvements in the telecommunications network and broadband services.
