



Notes to the financial statements For the period ended 31 March 2022

1. General information

Bryn Gilwern Energy Park Limited is a private company limited by shares, registered in England and Wales under the Companies Act 2006. The principal activity is as described in the directors' report and the registered office is stated on the company information page.

2. Accounting policies

2.1 Basis of preparation of financial statements

The financial statements have been prepared under the historical cost convention unless otherwise specified within these accounting policies and in accordance with Section 1A of Financial Reporting Standard 102, the Financial Reporting Standard applicable in the UK and the Republic of Ireland and the Companies Act 2006.

The preparation of financial statements in compliance with FRS 102 requires the use of certain critical accounting estimates. It also requires management to exercise judgment in applying the company's accounting policies.

The following principal accounting policies have been applied:

2.2 Going concern

During the period the company made a loss of £403,561, had net current liabilities and net liabilities of £403,560. The company is dependent upon the support of its parent company to continue operating and the board of directors have confirmed the support continues to be in place. The financial statements have been prepared on the going concern basis and do not include any adjustments that would be necessary should the support of the parent company be withdrawn.

2.3 Interest income

Interest income is recognised in profit or loss using the effective interest method.

2.4 Finance costs

Finance costs are charged to the statement of comprehensive income over the term of the debt using the effective interest method so that the amount charged is at a constant rate on the carrying amount. Issue costs are initially recognised as a reduction in the proceeds of the associated capital instrument.

2.5 Debtors

Short-term debtors are measured at transaction price, less any impairment. Loans receivable are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method, less any impairment.

2.6 Cash and cash equivalents

Cash is represented by cash in hand and deposits with financial institutions repayable without penalty on notice of not more than 24 hours. Cash equivalents are highly liquid investments that mature in no more than three months from the date of acquisition and that are readily convertible to known amounts of cash with insignificant risk of change in value.

2.7 Creditors

Short-term creditors are measured at the transaction price. Other financial liabilities, including bank loans, are measured initially at fair value, net of transaction costs, and are measured subsequently at amortised cost using the effective interest method.

2. Accounting policies (continued)

2.8 Financial Instruments

The company only enters into basic financial instrument transactions that result in the recognition of financial assets and liabilities like trade and other debtors and creditors, loans from banks and other third parties, loans to related parties and investments in ordinary shares.

Debt Instruments (other than those wholly repayable or receivable within one year), including loans and other accounts receivable and payable, are initially measured at present value of the future cash flows and subsequently at amortised cost using the effective interest method. Debt Instruments that are payable or receivable within one year, typically trade debtors and creditors, are measured, initially and subsequently, at the undiscounted amount of the cash or other consideration expected to be paid or received. However, if the arrangements of a short-term instrument constitute a financing transaction, like the payment of a trade debt deferred beyond normal business terms or in case of an out-right short-term loan that is not at market rate, the financial asset or liability is measured, initially at the present value of future cash flows discounted at a market rate of interest for a similar debt instrument and subsequently at amortised cost, unless it qualifies as a loan from a director in the case of a small company, or a public benefit entity concessionary loan.

Financial assets that are measured at cost and amortised cost are assessed at the end of each reporting period for objective evidence of impairment. If objective evidence of impairment is found, an impairment loss is recognised in the statement of comprehensive income.

For financial assets measured at amortised cost, the impairment loss is measured as the difference between an asset's carrying amount and the present value of estimated cash flows discounted at the asset's original effective interest rate. If a financial asset has a variable interest rate, the discount rate for measuring any impairment loss is the current effective interest rate determined under the contract.

For financial assets measured at cost less impairment, the impairment loss is measured as the difference between an asset's carrying amount and best estimate of the recoverable amount, which is an approximation of the amount that the company would receive for the asset if it were to be sold at the balance sheet date.

3. Employees

The company has no employees other than the directors, who did not receive any remuneration.

10. Reserves

Profit and loss account

The profit and loss account represents the accumulated profits and losses on the activities of the company, net of dividends.

11. Related party transactions

Included within amounts owed to group undertakings is loan and interest of £nil due to Bute Energy (Cambria) Limited, a company related by common directors. Interest at 6% was charged on the loan amounting to £12,157. A repayment of £19,951 was made during the year. The remaining balance of the loan and interest of £303,137 was also later repaid prior to the period end.

Included within amounts owed to group undertakings is loan and interest of £633,294 due to Bute Energy Development Holdings Limited, the parent company. Interest at 15.5% was charged on the loan amounting to £7,354. In the period the company received £625,940 in funding.

In the year the company was charged £41,753 in management charges from Bute Energy Limited, a company connected by common directors.

12. Controlling party

The company is controlled by Bute Energy Development Holdings Limited, the parent company. At the beginning of the period the company was controlled by Bute Energy (Cambria) Limited.

In the opinion of the directors there is no ultimate controlling party.
