Working Day means any day from Monday to Friday except for any bank or public holidays in England and Wales.

2. Construction

- Unless a contrary indication appears, any reference in this Deed to:
 any Secured Party, the Lender, the Borrower or any Party shall be construed so as to include its successors in title, permitted assigns and permitted transferees to, or of, its rights and/or obligations under the Pinance Documents;
 an attendment includes a supplement, novation, extension (whether of measurity or otherwise), restatement, re-enactment or replacement (in each case, however fundamental and whether or not more onerous or involving any change in or addition to the parties to any agreement or document) and amended shall be construed accordingly. parties to any agreement or document) and amended shall be construed accordingly;

 - c. assets includes present and future properties, revenues and rights of every description;
 d. disposal includes a sale, transfer, assignment, grant, lease, licence, declaration of trust or other disposal, whether voluntary or d. disposal includes a sact, transier, assignment, grand reads, assignment, and involuntary and dispose shall be construed accordingly;
 c. a Finance Document or any other agreement or instrument is a reference to that Finance Document or other agreement or
 - instrument as amended;
 - f. a person includes any individual, firm, company, corporation, government, state or agency of a state or any association, trust, joint venture, consortium, partnership or other entity (whether or nor having separate legal personality);

 g. a regulation includes any regulation, rule, official directive, request or guideline (whether or not having the force of law) of any
 - governmental, intergovernmental or supranational body, agency, department or of any regulatory, self-regulatory or other authority or organisation;

 - any rights in respect of an usset includes:
 (i) all amounts and proceeds paid or payable;
 (ii) all rights to make any demand or claim; and

- (iii) all powers, remedies, causes of action, security, guarantees and indepntities, in each case, in respect of or derived from that asset;
- i. the term this Security means any Security created by this Deed;
- an agreement, instrument or other document to which it is a party includes any agreement, instrument or other document issued in the relevant person's favour or of which it otherwise has the benefit (in whole or in part); and
- k. a provision of law is a reference to that provision as amended or re-enacted.
- 2.2. Clause and Schedule headings are for ease of reference only and do not affect the interpretation of this Deed.
- 2.3. Unless a contrary indication appears, a term used in any other Pinance Document or in any notice given under or in connection with any Pinance Document has the same meaning in that Pinance Document or notice as in this Beed.
- 2.4. An Event of Default is continuing if it has not been remedied or waived.
- 2.5. Any covenant of the Borrower under this Deed (other than a payment obligation which has been discharged) remains in force during the Security Period.
- 2.6. The terms of the other Phance Documents and of any other agreement or instrument between any Parties in relation to any Phance Document are incorporated in this Deed to the extent required to easife that any purported disposition, or any agreement for the disposition, of any freehold or leasehold property contained in this Deed is a valid disposition in accordance with section 2(1) of the Law of Property (Miscellaneous Provisions) Act 1989.
- 2.7. If the Lender considers that an amount paid to it under a Finance Document is capable of being avoided or otherwise set aside on the liquidation or administration of the payer or otherwise, then that amount shall not be considered to have been irrevenibly paid for the purposes of this Deed.
- 2.8. Unless the context otherwise requires, a reference to a Security Asset includes the proceeds of any disposal of that Security Asset.

3. Third party rights

- 3.1. Unless expressly provided to the contrary in a Finance Document, a person who is not a Party has no right under the Contracts (Rights of Third Parties) Act 1999 (the Third Parties Act) to enforce or to enjoy the benefit of any term of this Deed.
- 3.2. Nexwithstanding any term of any Pinance Document, the consent of any person who is not a Party is not required to rescind or vary this Deed at any time.
- 3.3. Any Receiver or any delegate or sub-delegate of the Lender or any Receiver may enforce and enjoy the benefit of any Clause which expressly confers rights on it, subject to paragraph (b) above and the provisions of the Third Parties Act.
